Foreword

I am pleased to have been asked to write a foreword for this Report covering the last five years of activity in the School of Nursing and Midwifery. It is clear that the School has gone from strength to strength over this time, building on its reputation for high quality teaching and research. I am impressed with the breadth of the teaching provision within the School, which provides a wide array of opportunities to match the ever more diverse needs of the profession in today's National Health Service. The focus on research-led teaching and care pathways is exactly what is needed for high quality patient-centred care. Other highlights include the new undergraduate Bachelor of Medical Science in Health and Human Sciences programme, which offers an exciting starting point for students to enter an array of clinical training opportunities, and the Postgraduate Diploma in Adult Nursing, another novel programme for graduates seeking to train as a Registered Nurse. The Department of Health, in partnership with the Nursing and Midwifery Council, the Health Professions Council and the Strategic Health Authorities, and the Quality Assurance Agency for Higher Education, undertook a major review of the School's programmes in 2006 and found many strengths and areas of good practice, including close working partnership with service providers.



The School has been equally successful in research, a fact which is most easily appreciated from the excellent outcome of the Research Assessment Exercise in 2008. There is a clear focus on three main themes of national importance (supportive care in later life; children, families and young people; workforce and practice development) and this Report has usefully collected together all of the publications and research awards that have resulted. It makes impressive reading. Many staff within the School have been recognised externally for their academic achievements. To pick only a few highlights, Dr Penny Curtis was awarded The Obesity Awareness and Solutions Trust's Research Prize for 2007, Paula Hancock received the International Nurse of the Year Award in 2009 and Professor Roger Watson was made a Fellow of the Royal College of Nursing and awarded a Fellowship from the Royal College of Surgeons in Ireland in 2009.

I have been Pro Vice Chancellor of the Faculty for 18 months now. One of the most important changes I have seen in that time is the far greater sense of collaboration both within the Faculty and between us and other Faculties. We are also in much greater control of our own destiny, which has helped to foster this spirit of collegiality. As you know, there is much talk at present about 'impact', especially with regard to the Research Excellence Framework that will replace the Research Assessment Exercise, but the impact of what Universities teach is also coming under greater scrutiny. Within our Faculty, there really is no difficulty in demonstrating to anyone the impact and benefit of what we do in terms of teaching and research. Health professions are an obvious public good: indeed, medicine has been described by the historian, Roy Porter, as the greatest benefit to mankind. As this Report makes clear, the School of Nursing and Midwifery is very well placed within the Faculty making a very significant contribution to the local, national and international health care agenda. It is ranked among the top ten in the UK for research that is considered world leading, offers outstanding teaching and has clear plans to build on this very successful foundation. I hope you enjoy reading this Report.

Introduction

It is a pleasure to present the School of Nursing and Midwifery report for 2005 – 2009. It has been a successful but challenging period as our portfolio of provision has significantly changed. The School maintains undergraduate programmes but our focus is primarily on postgraduate teaching and research.

New full time programmes for 2009 include an undergraduate programme that helps develop a comprehensive understanding of the health and social care environment equipping students for a variety of careers in health and social care and an innovative pre registration postgraduate programme leading to professional registration as an adult nurse. We have a wide range of undergraduate and postgraduate flexible Learning Beyond Registration modules developing the skills and competency of approximately 1500 qualified nurses and midwives across South Yorkshire and beyond. We are proud of our three online Masters programmes which attract students from across the world.

A highlight has been the School's success in the 2008 Research Assessment Exercise, in which we were ranked 10th in the UK for nursing research. The most recent National Student Survey once again confirmed that our students are very satisfied with their experience and the quality of our programmes. We have also been commended by the Nursing and Midwifery Council for our close partnership working with the NHS. We continue to attract postgraduate research students locally, nationally and internationally. We are proud that one of our PhD students has been elected to the prestigious post of 'Chief Female Students Co-ordinator in the Saudi Students' Clubs and Schools' Association. The Association represents all Saudi Arabian students who study in the UK and Ireland. Our International Visiting Students Scheme continues to be very popular in attracting students from across the world and we frequently have visits from international academics wishing to gain experience of health care education in the UK.

We continue to attract students of wide social background through the widening participation schemes. Work is continuing in this area as we develop progression agreements with local further education colleges. None of this would be possible without the hard work and dedication of our academic and support staff, who have worked tirelessly to contribute to the success of the School.

Overview

The School of Nursing and Midwifery has a long standing reputation for providing high quality teaching to health care practitioners. The School is recognised nationally and internationally for its innovative work in developing curriculum and learning experiences appropriate to the modern healthcare environment in which it operates. It has successfully risen to the challenge of providing professional education in an increasing diversity of care provider environments through its flexible, modular learning schemes, care pathway approaches to learning, and increasing use of blended learning approaches.

The School's programmes facilitate progression and achievement in ways that are both flexible and consistent with the needs of individual students and their employers. Teaching and learning strategies focus on the development of professional skills, knowledge and behaviours. Learning opportunities are constructed to support both lateral and upwards development of the student, from the point of registration up to, and including, advanced practice at postgraduate and doctoral levels. Flexible modular programmes provide opportunity for study across extended periods and allow learning to 'travel' with the student across different roles and employers. It is an expectation that students commencing programmes are able to articulate objectives related to the application of learning to their work situation and role development. The focus on all assessed work is the consideration of the student's work situation and the articulation of recommendations for the improvement of practice.

The School understands the importance of inter-professional learning (IPL) and collaboration in the provision of modern health services and is committed to delivery of IPL as a lifelong learning experience. The School's taught programmes are appropriate to multi-professional groups. Learning opportunities are designed to accommodate individual professional needs and to promote common shared values and concepts such as professional behaviours, the patient / client and family network as informed users and consumers of care services, the organisational context of care delivery and delivering effective care through integrated team approaches. Unless there is a specific uni-professional requirement all programmes are able to accommodate the needs of a wide range of professional groups.

Staff involved in teaching contribute to their academic discipline through research and related activities. As a result the programmes offered by the School are purposefully evidence based, research informed and they directly reflect current knowledge and practice.

Undergraduate Teaching and Continuing Professional Development

The School of Nursing and Midwifery offers a range of undergraduate programmes suitable for health care professionals from a variety of specialist backgrounds.

A recent review of undergraduate provision has resulted in several new programmes:

- BMedSci (Hons) Health and Social Care Studies
- BMedSci (Hons) Acute, High Dependency and Critical Care
- BMedSci (Hons) Neonatal Intensive Care
- BMedSci (Hons) Ongoing and Supportive Care
- BMedSci (Hons) Primary Care and Public Health

Each programme consists of several modules which can be accessed as part of a programme or as stand alone accredited modules, and whilst the programme audience is mainly nurses, many modules in these individual programmes are accessed by allied health professionals.

Extensive relationships with both local and national health and social care providers ensures that our educational provision reflects service needs and advances in health care policy and in response, the undergraduate portfolio is constantly changing as new modules are developed with NHS Trust partners.

Staff are passionate about the advancement of knowledge and the educational experience of students and continually strive to develop innovative approaches to teaching and learning that enable students to develop skills and competence consistent with Skills for Health and the NHS Knowledge and Skills Framework. All programmes are delivered by subject experts and the clinical focus and application to clinical practice this affords is commended by students.

Since 2009 the School has been delivering the Bachelor of Medical Science in Health and Human Sciences. This is a new three year full-time undergraduate degree programme that provides students with a comprehensive understanding of the health service environment and equips them with the skills and knowledge needed for a variety of rewarding careers in health and social care. In addition, the degree provides a relevant qualification for direct entry into careers such as the healthcare professions, health care management, health research, community project coordination, patient advocacy and health education. For students wishing to take up nursing, midwifery or allied health professions such as occupational therapy, physiotherapy or speech therapy, it is an appropriate basis for applications to relevant postgraduate diploma or Masters programmes.

Postgraduate Teaching

The School has a strong taught postgraduate portfolio that has seen several key developments in the last two years. The number of taught postgraduate students has grown sixfold since 2006 to 78 students. We offer a range of postgraduate programmes aimed at nurses and also allied health professionals. The programmes are designed to offer a blend of learning that enables theory to be integrated with practice.

The School offers the following postgraduate courses:

- Postgraduate Diploma in Adult Nursing – a groundbreaking two year full time programme for graduates seeking to train as a Registered Nurse.
- MMedSci Adult Nursing – a ‘top-up’ programme to enable graduates of the Postgraduate Diploma in Adult Nursing to achieve a Masters degree in nursing.
- MMedSci Advancing Practice – a two year part time programme designed for health practitioners across the professional spectrum.
- MMed Sci Advanced Nursing Studies – a completely online programme for nurses both nationally and internationally.
- MMed Sci Occupational Health Nursing – a completely online programme for nurses both nationally and internationally working in the field of Occupational Health.
- MMed(Midwifery)/MMedSci Maternity Nursing – a completely online programme for Midwives/Maternity Nurses both nationally and internationally.
- Postgraduate Certificate in Long Term Health Conditions

Our postgraduate programmes are delivered by staff who are keen to integrate research into their teaching. These postgraduate programmes draw strongly from the research themes in the School and comprise significant levels of internationally recognised research activities. The School is also an expert provider of online learning, having developed and recruited successfully to three online Masters programmes.

In addition, the School is currently developing postgraduate certificates in cancer care and neonatology, which together with the postgraduate certificate in long term conditions, will link with our ‘Masters framework’ that allows students to build their postgraduate certificates into diploma and full Masters awards.

Staff Research

Introduction

The School of Nursing and Midwifery has been at the forefront of research in the field since 2001 when it was awarded the top score of 5, along with only four other schools of nursing and midwifery in the United Kingdom, in the 2001 United Kingdom Research Assessment Exercise. Despite significant changes in the School following reorganisation in 2005 and also in the way research was assessed in the 2008 United Kingdom Research Assessment Exercise, the School remains in the top ten of nursing and midwifery schools in the United Kingdom with the following outcomes:

- 85% of our research profile is of at least international quality
- 50% of our research profile is of at least internationally excellent quality
- 15% of our research profile is of at least world-leading quality

Therefore, research in nursing and midwifery at the University of Sheffield remains strong, nationally leading and internationally competitive.

Research in nursing and midwifery at the University of Sheffield is organised into three themes:

- Supportive care in later life
- Children, families and young people
- Workforce and practice development

Each of these themes will be explored in more depth below but each has in common research that

- is user focused
- addresses theory and practice
- is multidisciplinary

In each theme we aim to address local and national agendas in health and social care but also to seek strong international collaborations. Within the University of Sheffield we are actively engaged in research collaborations with other schools and major research institutes. These include: the School of Health and Related Research (ScHARR); the Sheffield Institute for Studies on Ageing (SISA); and the Centre for the Study of Childhood and Youth (CSCY). These symbiotic relationships give rise to many creative research opportunities.

Our success in research is evident through capture of significant research grants from prestigious sources and in our publications and conference presentations. We aim to publish across a wide range of outputs. Of particular note are our GRIP (**G**etting **R**esearch **i**nto **P**ractice) reports which are aimed at making our research accessible to the various user groups with which we work. However, we also publish in

professional journals and high impact factor research journals to ensure that our work reaches our peers in practice and in the wider, international, scholarly community.

Our research activity and publications have been enhanced recently by international visitors including our International Visiting Students Scheme, our Leverhulme Visiting Professor and several visiting scholars. In addition, we have strong links through honorary, adjunct and visiting academic positions at many universities across the world.

READ

We regularly publish our newsletter, READ (**R**esearch **E**ndeavours **A**nd **D**issemination) which periodically summarises our research programmes, international activity and publications. *READ* is available electronically or in hard copy and if you wish to receive a copy then please inform our Research Administrator, Jane Flint (j.flint@sheffield.ac.uk). Supportive Care in Later Life



This research theme is concerned with exploring the ways partnerships can be formed between older people, families and paid carers in order to generate knowledge that contributes both to greater theoretical understanding and enhanced service delivery.

Research summary and principal aims

Work in this area has been a consistent focus of activity since the School of Nursing and Midwifery's inception in 1995 and contributes to the University of Sheffield's reputation as one of the foremost centres for the study of ageing.

By working closely with older people, family and paid carers we aim to explore the characteristics of, and factors that create 'enriched environments' of care where the quality of life of older people and their family carers is enhanced, and the job satisfaction and morale of staff is raised.

We have close links with several other departments in the University, especially the Sheffield Institute for Studies on Ageing (SISA), and well established international links, especially with Sweden.

Several significant streams of work have been taken forward, including:

Family carers

Work with family carers has been a feature of activity for over 15 years and has involved: the development of new assessment frameworks, together with colleagues in Sweden and Canada; the creation of a user-focused research and development centre for older people, families, practitioners and policy-makers in Sweden (ÄldreVäst Sjuhärads); continuing work with the information and communication technology based ACTION project in Sweden; participation with colleagues in SISA in a number of EU funded R&D projects; work with families caring for people with severe mental illness.

Senses Framework and Relationship-Centred Care

Work across the theme in education, dementia care, care homes, and with carers has seen the further elaboration of the Senses Framework and Relationship-Centred Care as a new model underpinning practice with older people and their families and education for practitioners.

This saw the emergence of new practice tools, based on the Senses Framework, for example, the CARE (Combined Assessment of Residential Environments) profiles which have attracted international interest, and the development of innovative dissemination methods using multi-media applications. Relationship-Centred Care and the Senses Framework currently underpin Help the Aged's major new initiative My Home Life, and are being used by the Care Commission in Scotland to inform new national standards for care homes.

National Care Home Research and Development Forum (NCRDF)

Work in care homes not only stimulated the development of the CARE profiles, but has also been instrumental in the launch of the National Care Home Research and Development Forum (NCRDF) consolidating links between academics, providers, users and practitioners in this vital area.

Adult protection and elder abuse

Adult protection and elder abuse has been a stream of the research group since 2004. A major Department of Health funded study over three years has concerned 'Partnerships and Regulation in Adult Protection' and there has also been a Project Management role within the UK Study of Elder Abuse and Neglect, funded by Comic Relief and the Department of Health.

Both of these studies have involved discussions with the Department of Health and the Scottish Executive and these are likely to be ongoing. The work has been taken forward through a Research into Practice for Adults (RIPFA) Change Project on Adult Protection and a scientific advisor role for a national research programme on Abuse, Neglect and Loss of Dignity in Care Settings for Older People, funded by the Department of Health and Comic Relief. Active international links have been established, particularly with colleagues in Europe and Canada. Current involvement in three EU funded and ESRC projects is ongoing.

Sexuality and older people

Working in close collaboration with colleagues at SISA, this stream of work focuses on the much neglected area of sexuality and ageing. Of particular interest are sexual and reproductive health issues across the life-course. Within this context, work has addressed various psychosocial aspects of health and healthcare, including barriers to accessing (sexual) healthcare services and the impact of health conditions upon psychological well-being.

End of life and palliative care

A number of funded studies have been undertaken around the following:

- Palliative care service evaluation and needs assessment (e.g. Marie Curie Cancer Care funded study)
- Providing palliative care in non-specialist settings (e.g. Help the Hospices funded study)
- Transitions to palliative care for older people (e.g. SDO funded study)

Children, Young People and Families



This research theme is concerned with exploring and theorising key issues of relevance to the health and well-being of children, young people and families with a view to generating and disseminating evidence to providers of health and social care.

Research summary and principal aims

Research in this theme reflects a commitment to the importance of the inclusion of the 'voice' of children and young people in research and theoretical development in the area of health and social care. Research therefore seeks to understand the perspectives of children and young people as well as those of adults and other family members to further understanding of health related issues. Much of the work undertaken in this theme is interdisciplinary. The theme benefits from strong research links with the Centre for the Study of Childhood and Youth, the Department of Sociological Studies and the School of Health and Related Research.

Identity and risk

One strand in the theme is concerned with identity and risk, relating in particular to obesity and to sexual health. Research has contributed to the development of knowledge in relation to children's and young people's experiences of being obese and the association between obesity and social exclusion. Further work has examined the experiences of parents of children with obesity. This research was awarded the 2007 David Kennedy Memorial prize for research by The Obesity Awareness and Solutions Trust (TOAST).

The focus on childhood obesity is located in broader concerns about children's and young people's health behaviours, including their eating practices. Work has also examined influences on children's food related understandings and how understandings are negotiated in the family to influence eating practices.

From a sexual health perspective, work has examined discourses around young people and sexual risk taking behaviour and the discursive construction of contraceptive use amongst young women. Research has also explored embodied aspects of contraceptive use.

Care contexts

A second strand in this theme focuses on care contexts. This strand is unified by a concern for how children, young people and families experience and interact with health, education and social care environments. As understandings of 'family' and particularly 'healthy family', may inform the work of practitioners in diverse care contexts, this has been one focus of activity.

Also in this strand is a concern for spatial aspects of care environments. A study funded by the ESRC has enabled children and young people to participate in research which explored their experiences of spatial aspects of hospitals and to inform the work of architects, planners and service providers in working towards more child friendly hospitals. Work exploring the relationship of clinic structures and practices on contraceptive use and sexual behaviour has added to this strand. A study funded by the Neighbourhood Renewal programme examined the impact of sexual health clinics, established within youth clubs, upon young people's sexual behaviour and attitudes.

Workforce and Practice Development



This research theme covers nurse leadership, education, routes of entry into nursing and the experience of being a nursing student or a nurse. This work is intended to inform nursing educators and health service workforce planners about issues relevant to retaining nursing students and stress and psychological morbidity amongst nurses.

The delivery of healthcare is dependent on the healthcare workforce and their assimilation of the most recent and effective methods of delivery. The ability of nurses to care for their patients and to adapt to the rapidly changing world of healthcare is interrelated.

The nursing workforce is affected by change and nursing students and newly qualified nurses have to adapt to changes throughout their education and early years in clinical practice. Research in this theme investigates the effect of delivering healthcare on the individuals who deliver it and also how new methods of delivery are assimilated and put into operation.

Research in this theme has included a wide range of projects based around changes introduced as a result of UK government policy in the NHS. This includes an evaluation of the role of Modern Matrons in the NHS, at the delivery end of healthcare but also includes evaluation of Cadet Nurses' schemes and mechanisms for ensuring the quality of nursing programmes at the educational end.

The work of midwives has been studied in relation to why they leave midwifery. The aim of this research has been to inform the UK Department of Health on how their policy initiatives have been implemented, on what does and doesn't work and also to inform professional nursing bodies – statutory and trade unions – about issues relevant to their activities.

In addition, the work also aims to contribute a nursing and midwifery voice to the growing body of knowledge on healthcare workforce issues which is also contributed to by other disciplines such as psychology, economics and management studies.

Collaboration in Leadership for Applied Health Research and Care (CLAHRC) for South Yorkshire- Stroke Theme

This significant programme of collaborative research brings together a range of research projects which take into account the entire care pathway within stroke, from awareness and prevention through self management and long term support and rehabilitation. In this way the School is actively engaged in leading and coordinating research that is innovative, timely and based on sound collaborative relationships with clinicians, commissioners, patients and carers.

Introduction

The School of Nursing and Midwifery has provided a portfolio of postgraduate research opportunities which include MPhil, PhD and DMedSci (Doctorate in Professional Health Care practice). Research students benefit from the 'very good training environment' which drew particular comment in the 2008 United Kingdom Research Assessment Exercise and are integrated into, and make a valued contribution to, the academic life of the School.

The majority of students registered for postgraduate research degrees with the School are experienced health care professionals who undertake their research studies on a part time basis while continuing to work in clinical or educational settings. However, the School welcomes candidates from the following overlapping categories:

The skills and experience expected of a postgraduate research student may be present at registration, explicitly taught, or developed during the course of the research. We encourage all research students to take every opportunity to develop research specific and generic skills and experience by accessing the University of Sheffield's Research Training Programme (RTP). In addition to the RTP units, the School of Nursing and Midwifery also provides a range of support mechanisms including research seminars which students are encouraged to attend. Supervisors are themselves supported by the Postgraduate Tutor and other senior academics through the School's postgraduate research supervisors' forum and they participate in a mentorship scheme with colleagues in the School and the broader University community. Supervisors may be drawn from the School of Nursing and Midwifery and the wider University as well as other academic and practice institutions.

International Visiting Scholar

Professor Li-Chan Lin, a Visiting Leverhulme Professor from National Ying-Ming University, Taiwan delivered a Leverhulme lecture entitled 'Traditional Chinese Medicine: putting it to the test' at the University of Sheffield on 4 February 2009. The event, which was chaired by Keith Burnett CBE, Vice-Chancellor of the University of Sheffield was well attended by university colleagues and lay people interested in Traditional Chinese Medicine (TCM).

Professor Lin explained the cultural and philosophical roots of TCM and introduced her own research into acupuncture involving randomised clinical trials on a wide variety of disorders including nausea and agitation. The message was that acupuncture seems to work, although the mechanisms are still poorly understood.

Professor Lin is a gerontology nurse with a main research interest focusing on the care of institutionalised residents. Her long-term research goal is to improve the quality of care in long-term care facilities. To achieve this goal, she has, during the last 16 years, investigated the factors that influence the morale of older people and then engaged in various independent nursing interventions in long-term care facilities in Taiwan. These investigations have included:

- training in swallowing for stroke patients
- pain management for care home residents with cognitive impairment
- intervention-reduced agitated behaviour in demented elders
- management of eating difficulties for elders with dementia

From 1997 to 2000 she was the director of the Institute of Clinical Nursing at the National Yang-Ming University. She was president of the Taiwan Long-Term Care Professional Association between 2005 and 2008. She is an editorial board member of the Journal of Clinical Nursing, and a peer reviewer for the BMC Complementary and Alternative Medicine, Public Health Nursing, Journal of Advanced Nursing, Journal of Clinical Nursing and the Western Journal of Nursing Research.
